1. BACKGROUND

The tender was floated in execution of Circular Ref" No. OP/CAB.39/1A dated 23rd February, 2018 from the Head of Public Service on Centralized Procurement of ICT Equipment and Services. Procurement of ICT equipment and services was consolidated under the State Department of ICT and Innovation.

- F10 did not submit a complete set of bank statement for 6months and manufacturer authorization
- F12 did not submit bank statement for 6 months
- F13 did not submit manufacturer authorization
- F14 did not submit manufacturer authorization
- F15 did not submit manufacturer authorization
- F16 had erroneously been recorded in Tender Number 6 during tender opening while in actual fact it was n tender number 5
- F18 did not submit not submit bid bond, bank statement for 6 months, reference letter from the bank, manufacturer authorization
- F19 did not submit manufacturer authorization
- F21 did not submit manufacturer authorization
- F24 did not submit manufacturer authorization
- F25 did not submit valid tax compliance certificate, bid bond, bank statement for 6 months, manufacturer authorization and sworn statement

3.3 **CONCLUSION**

Pursuant to clause 2.22.4 of instructions to tenderers suppliers F2,F4, F5,F7,F9,F10,F12,F13,F14,F15,F16,F18,F19,F21,F24,F25,F26,F27,F28,F29,F30,F31,F32,F33,F35, F36,F37,F38,F39,F40,F41 were found to be non- compliant and were not eligible for Technical Evaluation; The firms were therefore not compliant pursuant to clause 2.22.4 of instructions to tenderers and therefore did not proceed to the technical evaluation stage.

TECHNICAL STAGE 4.

In this stage, the bids were analyzed to determine compliance with technical specifications for the equipment as per the evaluation criteria set-out in the tender document. The criteria below was used to rate the technical responsiveness of the bidders. All the requirements had to be met for a tender to be considered responsive for the next stage of financial evaluation. The following table shows the technical minimum requirements that were evaluated:-

4.2 OBSERVATIONS

The evaluation committee noted the following during the technical evaluation:

F3 proposal did not have a storage subsystem, keyboard and pointing device, communication interface, integrated fingerprint reader, software and operating systems.

4.3 CONCLUSIONS

F3 was therefore technically non- responsiveness and did not qualify to proceed to the next evaluation stage. On the other hand, F1,F6 ,F7, F8, F11, F17, F20, F22, F23, F34, F42, were responsive and therefore proceeded to the financial evaluation.

5. FINANCIAL EVALUATION

Therefore the following bidders were subjected to financial Evaluations.F1,F6,F7,F8,F11,F17,F20,F22,F23,F34,F42 whose compliance results on financial evaluation **as shown below.**
