EVALUATION PROCESS

- 3. FINANCIAL/COMMERCIAL STAGE

1. PRELIMINARY STAGE

This stage of evaluation involved examination of the pre-qualification conditions as set out in the tender advertisement Notice or Letter of Invitation to tender and any other conditions stated in the bid document. All the under listed conditions had to be fulfilled in order for the bidder to be considered compliant and move to the next stage of evaluation.

The conditions set out in this stage were mandatory and all bidders were required to have attached all the required documentation and show evidence of compliance to be considered successful for the next stage of evaluation. Bidders that did not qualify in this stage were not considered for technical evaluation.

NB. There was no F47 (M/S Computer Revolution Africa) because that tender was erroneously opened but was later discovered that it belonged was under type 1 laptop.

OBSERVATIONS

- M/S Capital Premier & Affiliate did not fill the form of tender.
- M/S Elsim Enterprises did not attach a bid bond.
- M/S Namwoya Computer Solutions did not attach a business permit.
- M/S Beka Vista Systems did not provide audited accounts and bank statement.
- M/S Gevin Technologies has no reference letter from the bank, bank statement, manufacturer's authorization and warranty certificate. They also did not have a sworn statement.
- M/S Streamlan East Africa Ltd had no reference letter from the bank.
- M/S Kentek Solutions had no bank statements.
- M/S Blue Print Computers (K) Ltd had no bank statement.
- M/S Zephe Enterprises did not provide a bid bond, audited accounts, manufacturer's authorization and a sworn declaration.
- M/S Copier Force Ltd had a sworn statement that was not signed or stamped.
- M/S Pinnacle Multiprod did not provide a bid bond and manufacturer's authorization.
- M/S Softwise Enterprises and M/S Pentium Systems had no bank statement.
- M/S Joyvennah Agencies only provided one copy of the tender.
- M/S Limidi Ventures had no business permit.
- M/S Lenox General Supplies had no bid bond.
- M/S Brose Consulting Agency had no business permit, bank statement, sworn statement/affidavit and manufacturer authorization.
- M/S Weston Commodities Ltd had no sworn statement/declaration or affidavit.
- M/S Blue Print Computer Ltd and M/S Mbirwe Systems Ltd did not have bank statements.

CONCLUSION

Pursuant to clause 2.22.4 of instructions to tenderers the following suppliers were found to be non- compliant and therefore, were not considered for technical evaluation:-

2.TECHNICAL EVALUATION

••

In this section, the bids were analyzed to determine compliance with technical specifications for supply of desktop computers type 1 as per the evaluation criteria set-out in the tender document. The criteria below will be used to rate the technical responsiveness of the bidder. All the requirements must be met to be considered responsive for the next stage of evaluation. The criteria is as follows:-

a) Minimum Technical compliance

Determined by the information given by the tenderer concerning the equipment tendered. Minimum technical specifications must be met. Attach detailed specifications, drawings and catalogues of the equipment to be supplied.

b) Spare parts availability locally

Give a list of major replacement components, mandatory spare parts including tonners of the equipment during its life cycle.

This is to be determined by the information supplied by the tenderer as regards to local firms that deal with stocking of spare parts for the make of equipment. Letters from the local dealers are required. A physical check/due diligence on these dealers may be done to confirm the information.

c) After sales service plan

The supplier should provide an after sale service plan during the warranty period. Including a help desk in case of any queries.

OBSERVATIONS

- F2 Bidder did not have provision for anti-virus software.
- F3 Bidder provided documentation but their proposal did not meet the users minimum technical requirements i.e. the system memory, storage sub-system, optical drives, keyboard and audio, communication interface, OS, Software and power supply.
- F6 Bidder provided documentation but their proposal did not meet the users minimum technical requirements i.e. the system memory, storage sub-system, keyboard and pointing devices, OS, Software and there was no evidence of spare parts availability.
- F7 Bidder did not attach original manufacturer's brochure against which technical evaluation was to be undertaken.
- F8 Bidder did not attach original manufacturer's brochure against which technical evaluation was to be undertaken.
- F11 bidder did not meet the minimum technical specificatiopons for provision of the software bundle i.e Operating System, MS Office and anti-virus software.
- F20 brochures provided. Provides OS but does not commit to pre-installation.

Other than the processor and the memory the other minimum requirements are not specified.

MS Office and software are not mentioned.

No aftersales service plan provided.

- F21 The bidder indicates compliance to all user specifications but does not provide/commit to specific offers.
- F24 only provides standard 4GB System memory. Expandability to 8GB not indicated. Does not commit to providing anti-virus.
- F27 Original brochure provided but not highlighted and no response provided on our user technical specification. No evidence attached to show spare parts availability locally. No after sales service plan provided.
- F33 Inconsistency in information provided in the brochure and the specifications provided by the bidder. Memory specification in the brochure and the one proposed by the bidder is inconsistent. Display/graphics (pixels) not indicated in the brochure. Optical drive not provided in the brochure. Audio does not indicate stereo audio system with inbuilt speakers. Communication interface not factored in the brochure. I/O Interface port rj45 not provisioned I n the brochure. OS, MS Office and anti-virus the vendor does not commit to supply drivers with licenses and or back up CD.

- F34 Brochures and aftersales service plan not provided. Escalation matrix/help desk not provided.
- F36 Only provides system memory of up to 4GB against the required 4GB expandable to 8GB. Optical drive size is not indicated.
- F38 DVD drive not provisioned in the brochure. Storage subsystem provisioned in the brochure is up to 500GB, the required is 512GB however, the bidder indicates to provide capacity of 512 GB. This is inconsistent with the brochure.
- F39 The bidder has not provided their proposed specifications, only brochures provided. Storage subsystem of 500GB proposed, 512GB is required. Does not commit to pre-install OS and software. No warranty provided by the bidder.
- F42 The bidder has not provided their proposed specifications, only customized brochures provided. Bidder offered preloaded software without accompanying CDs. No warranty or aftersales service plan provided. No manufacturer's product data sheet provided. No evidence of availability of spare parts locally.
- F43 The bidder has not provided their proposal committing to comply with provided minimum specifications. In the brochure provided there is no indication of provision for OS, MS Office 2016 and anti-virus with licenses on CD.
- F44 Offer of CD in the brochure is inconsistent with what the bidder has committed to provide. No inbuilt speakers provisioned in brochure. Optical drive not provided in brochure.
- F45 The bidder has not provided their proposed specifications, only brochures provided. Does not commit to pre-install OS, MS Office and antivirus.
- F46 Antivirus not provisioned.
- F49 Optical drive not provided in brochure. No evidence of availability of spare parts locally.
- F50 Bidder did not commit to make provisions for i.e. MS Office 2016 licensed with CD and latest version of anti-virus with licensed CDs.
- F51 –No provisions for keyboard, mouse, audio utilities and Ethernet provisions in the brochure. No evidence of spare parts availability attached.
- F52 Does not commit to provide windows CD with delivery. Internal memory proposed is 500GB which is lower than requirement of 512 GB.
