It was noted that some bidders were attaching bid bonds while others were attaching tender securing declaration form as per the tender instructions. Upon further investigations it was noticed that there was a slight confusion on the tender advertisement. The tender had been advertised at the Ministry's website and in MyGov publication as an open tender while in the Tender document it was captured as reserved.

### **CONCLUSION**

The Tender evaluation team recommends that tender for supply and delivery of supply and delivery of wireless access point (advanced), as and when required, for financial years 2018/2019 and 2019/2020 to be re-advertised and also the Ministry to organize for a pre-tender conference to induct suppliers.
