BACKGROUND

The tender was floated in execution of circular OP/CAB.39/1A dated 23rd February, 2018 from the Head of Public Service on Centralized Procurement of ICT Equipment and Services. Procurement of ICT equipment and services was consolidated under the State Department of ICT and Innovation.

This was an open tender that was published on 21st August, 2018 in MyGov publication and the Ministry's Website. The tender was opened on 4th September, 2018 in the presence of bidder representatives. Thirty (30NO) bidders submitted their bids as follows:

Evaluation was done in three stages:-

- 1. PRELIMINARY STAGE
- 2. TECHNICAL STAGE
- 3. FINANCIAL/COMMERCIAL STAGE

1. PRELIMINARY STAGE

This stage of evaluation involved examination of the pre-qualification conditions as set out in the tender advertisement Notice or Letter of Invitation to tender and any other conditions stated in the bid document. All the under listed conditions had to be fulfilled in order for the bidder to be considered compliant and move to the next stage of evaluation.

The conditions set out in this stage were mandatory and all bidders were required to have attached all the above documentation to be considered compliant and successful. Bidders that did not attach any of the required documents were not considered for technical evaluation and subsequently were not to be considered in any other evaluation stage.

OBSERVATIONS

Firm 14

- -The Firm's tender validity period was less days than those required in the tender document which are 150 days.
- -The bid bond ends on 2nd January instead of 1st February 2019 when the validity period ends officially.

• Firm 24

- -did not have serialized documents as stated in the tender instructions.
- -did not have evidence of having supplied similar items in the last 3 years.

Firm 7

-did not have a sworn statement as required in the tender document.

• Firm 8

- -did not have an original Manufacturer Authorization.
- -did not have a bid bond.
- **Firm 13** was found to have been wrongly placed in tender no 13 instead of Tender no 14 during tender evaluation.
 - -the committee also noted that Firm no 5 was found to have been placed wrongly in tender no 14 instead of tender no 13.
 - -To correct the anomaly, the committee decided to evaluate the bids in the correct tender i.e Firm 13 was serialized as Firm 26 in Tender 14 and Firm 5 was serialized as Firm 30 on Tender no 13.

NB: The two documents are from the same firm (Computerways Limited)

• Firm 17

- -did not have trade license or single business permit as per the tender instructions.
- -did not have evidence of having supplied similar items in the last 3 years
- -did not attach an Original Manufacturer Authorization as required in the tender document.

• Firm 15

-had no bid bond

• Firm 21

- -did not provide copy of the tender document as stated in the tender document clause 2.17.1.
- -did not have Original Manufacturer Authorization.
- -did not have a sworn statement.

• Firm 25

-did not have bid bond.

• Firm 28

- -did not have Original Manufacturer Authorization.
- Did not have evidence of having supplied similar items in the last 3 years as required in the tender instructions.

Note: F3, F7, F8, F14, F15, F17, F21, F24, F25, and F28 were found to be non-compliant therefore were not considered for any other evaluation stage.

CONCLUSION

• Pursuant to clause 2.22.4 of instructions to tenderers the following suppliers were found to be compliant and therefore, were considered for technical evaluation:-

• Firm No 16

- -the committee did evaluation based on the copy of the tender document.
- -the firm had attached the technical specifications and brochures in the copy of the tender document.

• Firm no 9

-did not have after sales service plan and spare part availability as required in the tender document.

Firm 11

-did not have after sales service plan as per technical criteria in the tender document.

• Firm 27

- did not have after sales service plan and spare part availability as required in the tender document.
- An observation made was that most firms were quoting HP model no m607 series.
- For technical compliance on the item of 'first page out' a speed of 0 to 9 secs is within the internationally accepted threshold by all printer manufacturers and therefore the committee gave waiver for all bidders.

Note: F9, F11 and **F27** were found to be non-compliant therefore were not considered for any other evaluation stage.

3. FINANCIAL/COMMERCIAL STAGE

FINANCIAL EVALUATION CRITERIA

- i) Tenderers with an average turnover of Kshs. 5 million and above will be considered. Tenderers shall get reference letters from their banks indicating the lines of credit available to them including any overdraft facilities as part of the financial bid.
- ii) The lowest evaluated financial bid i.e. the unit cost, will be considered per item. If there is a discrepancy between words and figures the amount in words will prevail.
