1. BACKGROUND

The tender was floated in execution of Circular Ref: No. OP/CAB.39/1A dated 23rd February, 2018 from the Head of Public Service on Centralized Procurement of ICT Equipment and Services. Procurement of ICT equipment and services was consolidated under the State Department of ICT and Innovation.

This was an open tender that was published on 21st August, 2018 in MyGov publication and the Ministry's Website. The tender was opened on 3rd September, 2018 in the presence of bidder representatives. Fifty (50NO) bidders submitted their bids as follows:-

3. PRELIMINARY TENDER EVALUATION STAGE

This stage of evaluation involved examination of the pre-qualification conditions as set out in the tender advertisement Notice or Letter of Invitation to tender and other conditions stated in the bid document..

The conditions set out in this stage were mandatory and all bidders were required to comply in order to be eligible for the next stage of evaluation. The following table indicates Compliance(C) or Non-compliance (NC) of the 50 bidders to the criteria set out for the preliminary evaluation.

3.2 OBSERVATIONS

During the preliminary evaluation the following observations were made

- F1 did not provide evidence of having supplied similar items in the last 3 years and did not provide a complete set of audited accounts.
- F2 did not attach manufacturer authorization letter
- F3 did not attach sworn statement or declaration
- F7 submitted accounts for the last 3 years but did not submit bank statement for the last 6 months.
- F10 did not submit bid bond, bank statement for the last 6 months, and reference letter from the bank, manufacturer authorization and sworn declaration.
- F11 did not have bank statement for 6 months and Manufacturer authorization letter.
- F12 did not have bank statement for the 6 months.
- F13 did not attach the following, valid trade license or single business permit, bid bond, audited accounts and bank statement, letter from the bank, manufacturer authorization, declaration statement and the document was not sequentially serialized.
- F15 did not submit audited accounts for 2015, bank statements and manufacturer's authorization
- F16 did not attach bank statement, letter from the bank, manufacturer authorization and sworn statement.
- F17 did not submit a copy of the tender document, bank statements for 6 months, letter from the bank, evidence of having supplied similar items in the last 3 years, manufacturer authorization and sworn statement.
- F18 did not submit 2017 audited accounts, bank statement for the last 6 months, bank reference letter, and manufacturer authorization letter.
- F20 did not submit bank statements and audited accounts for 2016 and 2015
- F22 did not provide a manufacturer's authorization, bank reference letter and a sworn statement.
- F23 did not submit bank statements
- F24 did not submit manufacturer authorization
- F26 did not manufacturer authorization
- F27 did not reference letter from the bank.
- F28 did not attach manufacturer authorization letter.
- F29 did not submit a bank statement and bank reference letter from the bank
- F31 did not submit duly filled, signed and stamped business questionnaire, bank reference letter, manufacturers authorization, and sworn statement.
- F32 did not submit manufacturer authorization letter.
- F33 submitted bank statement for 5 months, no bank reference letter and manufacturers authorization
- F34 did not submit bank statement for 6 months and manufacturers authorization
- F35 did not submit complete set of bank statements and manufacturers authorization
- F36 did not submit manufacturers authorization and audited accounts for 2017.
- F37 did not submit manufacturer's authorization and bank reference letter.
- F38 have attached 5 month bank statement
- F39 did not submit bid bond, bank reference letter, manufacturer authorization letter, and audited accounts for 2017.
- F40 did not submit bid bond, bank statement for 6 months, bank reference letter, manufacturer authorization and sworn statement.
- F42 did not submit business permit, bid bond, evidence of having supplied similar goods, audited accounts, bank statements, bank reference letter, manufacturer authorization and declaration statement.

- F43 did not submit bid bond, evidence of having supplied similar items, manufacturer's authorization and a reference letter from the bank.
- F46 did not submit bank statements for 2 months, business permit and a sworn statement
- F48 did not submit audited accounts and bank statements.
- F50 submitted audited account for 2016 only.
- It was noted that during tender opening, F50 was erroneously recorded as F16 under Tender Number 6 and was therefore moved to Tender Number 5 and evaluated accordingly.

3.3 CONCLUSION

F1, F2, F3, F7, F10, F11, F12, F13, F15, F16, F17, F18, F20, F22, F23, F24, F26, F27, F28, F29, F31, F32, F33, F34, F35, F36, F37, F38, F39, F40, F42, F43, F46, F48 and F50 were therefore not compliant pursuant to clause 2.22.4 of instructions to tenderers and therefore did not proceed to the technical evaluation stage.

4. TECHNICAL STAGE

In this stage, the bids were analyzed to determine compliance with technical specifications for the equipment as per the evaluation criteria set-out in the tender document. The criteria below was used to rate the technical responsiveness of the bidders. All the requirements had to be met for a tender to be considered responsive for the next stage of financial evaluation. The following table shows the technical minimum requirements that were evaluated:-

4.2 OBSERVATIONS

The evaluation committee noted the following during the technical evaluation:

- F6 did not provide the latest version of MS Office 2016 licenses with CDs and did nor propose to provide the latest version of anti-virus.
- F8 proposal did not provide MS Office 2016 licensed with CDs, integrated finger reader, stereo audio system, combo microphone in/audio out.
- F14 did not have display size 15.6'and communication interface 802.11 a/g/n (WAP2 Enterprise-compatible)

4.3 CONCLUSIONS

F6, F8 and F14 were therefore technically non responsiveness and did not qualify to proceed to the next evaluation stage. On the other hand, F4, F5, F9, F19, F21, F25, F30, F41, F44, F45, F47 and F49 were responsive and therefore proceeded to the financial evaluation.
