KENYA INFORMATION AND COMMUNICATIONS ACT, 2009

CALL FOR APPLICATIONS

IN ACCORDANCE with Section 102 of the Kenya Information and Communications Act ("the Act") the Cabinet Secretary for ICT, Innovation and Youth Affairs declares vacancies in the position of Member of the Communications and Multimedia Appeals Tribunal ("the Tribunal") and invites qualified candidates to apply for the post.

Women, youth, persons with disabilities and those from minorities and marginalized groups are encouraged to apply.

A. POSITION OF MEMBER OF THE TRIBUNAL

Under Section 102(1)(b) the Tribunal shall consist of at least four (4) persons possessing knowledge and experience in media, telecommunication, postal, courier systems, radio communications, information technology or business practice and finance, and who are not in the employment of the Government, the Media Council or the Communications Authority of Kenya.

B. TERMS OF SERVICE

The Members of the Tribunal shall hold office for a period of three (3) years and shall be eligible for re-appointment for another term subject to a maximum of two terms.

C. HOW TO APPLY

- All applications (manual and online) shall be accompanied by detailed curriculum vitae, copies of relevant academic and professional certificates, testimonials, telephone number and email.
- A copy of the National Identity Card or Kenyan Passport shall be appended.
- All applications shall be clearly marked, "**Application for position of Member of the Communications and Multimedia Appeals Tribunal**" and submitted in any **ONE** of the following ways:

- 4. -Directorate of Criminal Investigation (certificate of good conduct)**
